## BCAG ACHIEVES TWO WINS

A better parking strategy for the bottom of the 5<sup>th</sup> Concession and at the end of Trew Avenue and an amendment to Tiny's Official Plan are just two successes achieved by the **Bluewater Community Action Group (BCAG)** on behalf of local residents since last fall. BCAG was introduced in the Fall 2018 issue of this newsletter. Comprising board members from the Bluewater Georgina Wendake Beaches & Ratepayers Association, the Bluewater Dunes Ratepayers Association and the Bluewater Dunes Protection Association, BCAG engages with Tiny Township Council, staff and concerned citizens to protect, manage and maintain our community beaches. The BCAG does not hibernate during the winter months! Oh no. We have been hard at work and our meetings with Tiny councillors have been fruitful. Here's an update.

### Revised parking strategy

The BCAG has been actively encouraging changes to the township's Parking Strategy as paid parking has created serious safety and overcrowding issues on our roads and beaches. With the help of resident input, deputations to Council and collaborative consultations with Council members, paid parking has been removed from both the 5<sup>th</sup> Concession and Trew Ave. Permit parking will remain as it offers our neighbours better access to our community beaches. Remember, BCAG is committed to good beach access for all Tiny taxpayers.

### Revised Official Plan and Recreation Master Plan

Another concern that BCAG addressed with Tiny Council and staff was the wording in the Official Plan (OP) draft and the Recreation Master Plan (RMP) draft. The OP had originally labelled Bluewater Beach a "Major Beach Park". We successfully had this changed to "Beach Park with a Master Plan," which will help protect the dunes. Bluewater had also been labelled a "Major Water Park" in the RMP. This was inconsistent with the OP and misleading, as Bluewater Beach is a community beach with a restoration element. In addition, "Major Water Park" could create an impression that facilities such as washrooms, slides, shade, picnic tables, etc. may be available, which is not the case. As a result of BCAG efforts, "Major" has been removed from both the Official Plan and Recreation Master Plan and replaced with "Beach Parks with Master Plans."

### Small victories!

Moving forward, BCAG always has work to do. We are seeking confirmation from the township that it will uphold an existing motion from Council that Blocks A and B will remain community beach and not part of "Bluewater Beach Park". Tiny owns Blocks A and B, which are narrow strips of shoreline that stretch from Bluewater Beach Park to the Cleopatra, much of which is currently under water due to the high water levels. All BGW, BDPA and BDRA members will be interested in this outcome as it will affect all of us. Watch for more on this in a future issue. Urgently needed signage noted hereafter.

ROAD FLOODING UPDATE

As you may be aware Tiny Beaches Road South saw unprecedented road flooding this year between the 5th and 6th concessions. The flooding caused severe access issues for residents, as well as significant vehicle and property damage.

The flooding situation was a real eye-opener to many who were affected by it. This ordeal has identified that the current drainage and infrastructure of our roads are not adequate to handle drainage from the snow and rain. We have been in contact with the township concerning this issue and have seen some temporary assistance to alleviate the immediate situation.

We are continually communicating with the township to find a permanent solution. We look forward to building a working partnership with the township to meet the residents' and the township's needs. We will keep you updated on the process.

## SIGN UP to receive "THE TINY COTTAGER" ONLINE



Your BGWBRA is the largest association of 17 shoreline groups. Pressing concerns going forward will initiate FoTTSA to take notice of the diminishing residential beach front use in our communities from Wasaga Beach to Thunder Beach.

Now you can receive a digital version of *The Tiny Cottager*, a newsletter published twice yearly by the Federation of Tiny Township Shoreline Associations (FoTTSA), by signing up on the federation's website:

You'll also receive *FoTTSA Flash*, an e-newsletter published 5-6 times a year. To protect your privacy, FoTTSA keeps all email addresses confidential, and does not share them with any other organization.

FoTTSA is an umbrella organization that represents the interests of participating beach associations in Tiny Township. FoTTSA reports highlights of every Council meeting, defends shoreline owners' interests in discussions with Tiny Township (e.g., the development of Tiny's new Official Plan), tests lake water in over 100 locations every other summer, and much more. Bluewater Georgina Wendake Beaches and Ratepayers Association is a member of FoTTSA.

## SIGN UP for TINY CONNECTS

The Township of Tiny has launched a new notification system that enables you to receive news, information and alerts. When the township issues a notification about a potential safety hazard or concern, anyone who opts in will receive a message on the voice or text communication methods provided. The Township may ask that you confirm that you have received the message. Once you confirm, you will not be contacted by any subsequent methods regarding that particular notification. If you do not confirm, the system will continue to attempt to reach you at all of the contact paths that you have registered.

Once you have created an account and added your contact information, you can choose from a list of optional notifications to receive. The information you provide will be protected and not used for any other purpose.

Choose from these categories of notifications:

- **Stay Informed** - learn about road closures, burn bans, water restrictions and more
- **Participate** - hear about community events, recreation programs and public meetings
- **Be prepared** - receive alerts about pending and existing emergencies

You can stop receiving emergency alerts and optional notifications at any time by removing your contact information from your profile.
